Budget Highlights: Incentive Expenditure Trends

- Budget over 3 years: R17.8 billion
- Additional R1,358 billion allocated for 2021
- High 2021 baseline, spending in the Industrial Financing programme is expected to decrease at an average annual rate of 4.8 per cent, from R6.2 billion in 2021/22 to R5.4 billion in 2024/25.

Budget Highlights: Focus Area

Agriculture Blended Finance:

 Blended Finance Programmes: Farmer Development and Post-settlement Support: R6.8 billion

Department of Tourism:

Tourism Equity Fund: R360 million

New business bounce-back scheme will be launched:

- R15 billion: Small Business Loan Guarantees support mechanism
- R5 billion: Business Equity-Linked Loan Guarantee support mechanism
- Facilitated through participating banks and development finance institutions



Extension of Sunset clause

Research and Development Sunset clause:

- The R&D tax incentive sunset clause extended from 30 September 2022 to 31 December 2023.
- DSI call for comments on the review of the R & D Tax Incentive
- WG Submission to DSI: Policy and Administrative

Extension of Sunset Clause

Section 12L Energy Efficiency Tax Incentive:

 Energy Efficiency Tax Incentive sunset clause extended to 1 January 2023 to 31 December 2025.

Jobs Fund Call for Proposal

- Call for proposals open from 17 Feb 28 March
- Focus areas:
 - Enterprise Development;
 - Support for Work Seekers and;
 - Institutional Capacity Building
- Funding requirements: Minimum grant size
 - R10 million for applications submitted under the Enterprise Development and Support for Work Seekers funding windows and;
 - R5 million under the Institutional Capacity Building funding window



Social Employment Initiative

- Call for proposals
- 'Work for the common good' refers to work that contributes to public goods and services, rather than private ones.
- Supports the Sustainable Development Goals and improves the quality of life in communities,
- Beneficiaries
 - Disadvantaged communities and groups
- Focus areas:
 - Community safety;
 - Health and Community care;
 - Youth Support and Recreation;
 - Support for digital inclusion
 - Informal settlement upgrading
 - Educational support
 - Greening
