New procedures, systems and SARS implementations



#### **VAT registration process**

- All new applications for VAT registration will be subjected to a more stringent registration process which could include the requirement that the applicant present themselves (in person) to the branch closest to where the business enterprise is located;
- SARS will issue the applicant with a letter setting out supporting documents required for the validation of the registration;
- Applicants are expected to visit a branch in person, the visit must be pre-booked on the SARS website by clicking on the 'Book an Appointment' icon;
- All supporting documents that are required for registration validation may be submitted via eFiling or at the branch on the day of the appointment; and
- VAT registration will only be effected when SARS has satisfied itself that the application is lawful.



#### **VAT registration process - SAIT Submission**

- 1. Will additional appointments (capacity) be made available within the SARS branches to accommodate the increased demand?
- 2. Will the appointment be initiated by the taxpayer or by the SARS official verifying the VAT application?
- 3. Will SARS reinstate physical branch visits for other service offerings?
- 4. Considering the file size limit on eFiling, will SARS allow for the submission of supporting documents via the SARS Online Query System?
- 5. What is the official turnaround time for the finalisation of the VAT applications and when will this timeline commence?
